Eye Contact: Move victim away from exposure and into fresh air. Flush eyes with plenty of water for at least 15 minutes while

THRESHOLD LIMIT VALUE: EFFECTS OF OVEREXPOSURE Not Established for Mixture-See Section 2.

Eye Contact: Causes irritation. Based on product testing, product is severely irritating to eyes.

Skin Contact: Harmful if absorbed through the skin. Causes irritation. Prolonged or repeated liquid contact can result in defatting

and drying of the skin which may result in skin irritation and dermatitis.

Inhalation: Vapors are irritating to the nose, throat and respiratory tract. High vapor concentrations may cause central nervous

system depression.

Ingestion: Harmful if swallowed; may produce central nervous system depression. Ingestion of product may result in vomiting;

aspiration (breathing) of vomitus into the lungs must be avoided as even small quantities may result in aspiration

pneumonitis.

Xylene is not known to be mutagenic, carcinogenic or a skin sensitizer. However, the available experimental data are Carcinogenicity:

limited and insufficient to assess carcinogenic potential. Xylene is not listed as a carcinogen by NTP, IARC or OSHA.

Target Organs: A six week inhalation study with Xylene produced hearing loss in rats. Laboratory animals exposed by various routes

to high doses of Xylene have exhibited effects in liver, kidneys, lungs, spleen, heart, blood and adrenals

Developmental: Xylene produced limited evidence of developmental toxicity in laboratory animals. Inhalation and oral administration

of Xylene resulted in decreased fetal weight, increased incidences of delayed ossification, skeletal variations and

Medical Conditions Aggravated by Exposure: Pre-existing eye, skin and respiratory disorders may be aggravated by exposure to this product.

Exposure to high concentrations of this material may cause irregular heartbeats (arrhythmias). Persons with pre-

existing heart disorders may be more susceptible to this effect.

Chronic Effects: This product contains Ethyl Benzene. A draft report on a study conducted by the National Toxicology program states

that lifetime inhalation exposure of rats and mice to concentrations of Ethyl Benzene (750 ppm) resulted in increases in certain types of cancer, including kidney tumors in rats and lung and liver tumors in mice. These effects were not observed in animals exposed to lower concentration of Ethyl Benzene (75 ppm or 250 ppm). The draft report does

not address the relevance of these results to humans.

The International Agency for Research on Cancer has evaluated ethylbenzene and classified it as a possible human carcinogen (Group 2B) based on sufficient evidence for carcinogenicity in experimental animals, but inadequate

evidence for cancer in exposed humans.

This product contains 2-Butoxy ethanol. Studies in experimental animals have produced damage to the red blood cell

by inhalation, skin absorption and ingestion. Toxic liver effects in male rats were also observed.

SECTION 7 -- REACTIVITY DATA

Stability: Stable; however forms peroxides of unknown stability.

Conditions to Avoid: Heat, sparks and flame.

Incompatibility (Materials to Avoid): Strong oxidizing agents like liquid chlorine or concentrated oxygen, concentrated nitric and sulfuric acids, halogen

and molten sulphur.

Hazardous Decomposition Products: Thermal decomposition may yield carbon dioxide and carbon monoxide.

Hazardous Polymerization: Will not occur.

SECTION 8 -- SPILL OR LEAK PROCEDURES
